



Privacy Notice (How we use pupil information)

The categories of pupil information that we collect, hold and share include:

- Personal information – e.g. names, unique pupil numbers, date of birth, gender and addresses .
- Characteristics – e.g. ethnicity, language, religion, nationality, country of birth, mode of transport, previous setting, in care information, armed services information and free school meal eligibility.
- Attendance information – e.g. number of absences and absence reasons.
- Assessment information – e.g. national curriculum assessment results.
- Relevant medical and dietary information.
- Information relating to SEND.
- Behavioural information – e.g. number of temporary exclusions.
- Parental and emergency contact information.

Why we collect and use this information

We use the pupil data:

- to support pupil learning.
- to monitor and report on pupil progress.
- to provide appropriate pastoral care.
- to assess the quality of our services.
- to comply with the law regarding data sharing.
- to safeguard pupils.

The lawful basis on which we use this information

We collect and use pupil information under the following Articles of the General Data Protection Regulation.

Article 6 Legal obligation: the processing is necessary for us to comply with the law and for the performance of tasks carried out in the public interest”.

Article 9 Processing is necessary to protect the vital interests of a data subject or another individual where the data subject is physically or legally incapable of giving consent and processing is necessary for reasons of substantial public interest on the basis of UK law.

Collecting pupil information

Whilst the majority of pupil information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the General Data Protection Regulation, we will inform you whether you are required to provide certain pupil information to us or if you have a choice in this.

Storing pupil data

We hold pupil data for the period of time the child is in school , it is then passed onto their next school. If this is not possible then we hold data from their DOB plus 25 years.

Who we share pupil information with

We routinely share pupil information with:

- Pupils’ destinations upon leaving the school
- Our local authority (Surrey County Council)
- The Department for Education (DfE)
- The NHS
- Educational professionals



Why we share pupil information

We do not share information about our pupils with anyone without consent, unless the law and our policies allow us to do so.

We share pupils' data with the Department for Education (DfE) on a statutory basis. This data sharing underpins school funding and educational attainment policy and monitoring.

We are required to share information about our pupils with the (DfE) under regulation 3 of The Education (Information About Individual Pupils) (England) Regulations 2013.

The National Pupil Database (NPD)

The NPD is owned and managed by the Department for Education and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform

independent research, as well as studies commissioned by the Department. It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

We are required by law, to provide information about our pupils to the DfE as part of statutory data collections such as the school census and early years' census. Some of this information is then stored in the NPD. The law that allows this is the Education (Information about Individual Pupils) (England) Regulations 2013.

The department may share information about our pupils from the NPD with third parties who promote the education or well-being of children in England by:

- conducting research or analysis
- producing statistics
- providing information, advice or guidance

The Department has robust processes in place to ensure the confidentiality of our data is maintained and there are stringent controls in place regarding access and use of the data. Decisions on whether DfE releases data to third parties are subject to a strict approval process and based on a detailed assessment of:

- who is requesting the data
- the purpose for which it is required
- the level and sensitivity of data requested: and
- the arrangements in place to store and handle the data

To be granted access to pupil information, organisations must comply with strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data.

Requesting access to your personal data

Under data protection legislation, parents and pupils have the right to request access to information about them that we hold. To make a request for your personal information, or be given access to your child's educational record, contact the person with responsibility for data protection via the school

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed;
- claim compensation for damages caused by a breach of the Data Protection regulations
